

ORDINANCE 2016-1700

AN ORDINANCE AMENDING THE CITY OF MURRAY CODE OF ORDINANCES §52.09 SUBSECTION (B) AND SUBSECTION (D) BEING AN ORDINANCE DEFINING THE SCHEDULE OF RATES CHARGED TO USERS OF THE WASTE WATER TREATMENT SYSTEM BASED ON THE USER'S RESPECTIVE VOLUME OF METERED WATER CONSUMPTION.

WHEREAS, the City of Murray Finance/Personnel Committee met on the 24th day of March, 2016 to discuss a decrease in the waste water rates for customers living inside and outside the city limits; and

WHEREAS, the decrease is a result of a review of waste water rates for inside and outside customers; and

WHEREAS, the committee recommends a reduction in waste water rates for inside and outside customers.

WHEREAS, the City of Murray Finance/Personnel Committee has reviewed and discussed the following proposed rate increases to the City Of Murray Code Of Ordinance §52.09(B) and believe that the proposed changes are reasonable and necessary.

BE IT ORDAINED by the City Council of the City of Murray, as follows:

AMENDMENT I. ADDITIONS, ASSERTIONS & CHANGES:

That Section §52.09(B) and (D) is amended and revised in the following respects:

§52.09 RATES AND CHARGES.

(B)(1) Waste Water rate schedule for inside city customers.

The rates for each year subsequent to CY 2018 shall remain unchanged until such time as amended by ordinance.

(D) Each customer applying for a sanitary sewerage connection to the Murray Water and Sewerage System shall pay the fee set by the following sewer tap-on schedule:

(1) Sewer tap-ons, inside city, family residence – Effective 07/01/2016

- (a) ~~\$650~~ 1,500 for each single-family residence.
- (b) ~~\$250~~ 600 for each additional unit located within the same structure.

(2) Sewer tap-ons, outside city – Effective 07/01/2016

- (a) ~~\$900~~ 2,100 for each single-family residence.
- (b) ~~\$350~~ 840 for each additional unit located within the same structure.

(3) In the event the cost to the city exceeds the above tap-on fees, a determination of the actual cost shall be made by the Director of Public Works and such cost shall be the responsibility of the water or sewer customer.

(4) The above tap-on fees are in addition to the water and sewer rates presently in effect or which may hereafter be adopted.

Nothing in this Ordinance hereby adopted shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as cited in this Ordinance; nor shall any just or legal right or remedy of any character be lost impaired or affected by this Ordinance.

All other sections and provisions of the Ordinances for the City of Murray, not specifically amended herein, shall remain in full force and effect and shall not be considered amended and shall be incorporated by reference as if fully stated herein.
