

ORDINANCE 2019-1770

AN ORDINANCE AMENDING CITY OF MURRAY CODE OF ORDINANCES CHAPTER 32 DEPARTMENTS, BOARDS, AND COMMISSIONS, SPECIFICALLY §32.06 BOARD OF ZONING ADJUSTMENT COMMISSION, MEMBERSHIP, TERM AND VACANCY IN ORDER TO INCREASE THE NUMBER OF MEMBERS ON THE BOARD IN ORDER TO INCREASE EFFICIENCY AND BETTER SERVE THE COMMUNITY.

WHEREAS, the City of Murray desires to amend Chapter 32, §32.06 in order to increase the number of members on the Board of Zoning Adjustment Commission to increase efficiency and better serve the community.

WHEREAS, the Murray City Council has reviewed and discussed the following proposed changes to Chapter 32, §32.06 of the City Of Murray Code Of Ordinances and believe the changes are reasonable and necessary.

BE IT ORDAINED by the City Council of the City of Murray, as follows:

AMENDMENT I. ADDITIONS, ASSERTIONS & CHANGES:

CHAPTER 32: BOARD OF ZONING ADJUSTMENT COMMISSION

Subchapter §32.06 is amended to read in its entirety as follows:

§32.06 MEMBERSHIP, TERM AND VACANCY.

(A) The Board of Zoning Adjustments (BZA) shall consist of ~~five (5)~~ seven (7) members, all of whom must be citizen members. Citizen members may be any citizen who is not an elected official, appointed official, or public employee of the city or county. The number may be increased or decreased by action of the Mayor, subject to approval of the city Council. However, at no time shall the membership be fewer than three (3) members or more than seven (7) members. No more than two (2) members of the BZA may be citizen members of the Planning Commission. The Mayor shall appoint the members of the BZA. All vacancies shall be filled within sixty (60) days by the Mayor or as otherwise provided for in KRS 100.217(5).

Nothing in this Ordinance hereby adopted shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as cited in this Ordinance; nor shall any just or legal right or remedy of any character be lost impaired or affected by this Ordinance.

All other sections and provisions of the Ordinances for the City of Murray, not specifically amended herein, shall remain in full force and effect and shall not be considered amended and shall be incorporated by reference as if fully stated herein.
