

MINUTES OF THE COUNCIL

February 9, 2023

6:30 P.M.

The Murray City Council met in regular session on Thursday February 9, 2023, at 6:30 p.m. in the Council Chambers at City Hall with Mayor Bob Rogers presiding.

Mayor Bob Rogers called the meeting to order and welcomed Council members, staff, and guests.

After a moment of reflection, Mr. McCuiston led the pledge.

The minutes of the Council meeting of January 26, 2023, were presented for approval.

Mr. Bohannon moved for approval of the minutes; seconded by Dr. Strieter. All members present voted Aye.

Mayor's Report: Mayor Rogers yielded his time to allow, Mr. Paul Wood to give an update, on the Water Treatment Plant. Mr. Wood reviewed the treated amount of water, used by the city, by the day. Mr. Wood went over the increased usage over the last five years and addressed the impact of our growing city. A new water treatment plant was recommended if the city continues to grow.

Mayor Rogers recognized Mr. Ben Ballard, owner of Tap 216, to share why he would like for Ordinance 2023-1839 to pass. Mr. Ballard stated by passing the ordinance, it would increase his sales, by not turning away, customers on Sunday. Mr. Ballard represented other businesses, as well as his own, stating this not only helps their small businesses, but also helps bring in revenue for the city.


