MINUTES OF COUNCIL

April 28, 2016 6:30 P.M.

The Murray City Council met in regular session Thursday, April 28, 2016, at 6:30 p.m. in the Council Chambers of City Hall with Mayor Jack Rose presiding.

After discussion, **Chair Hudspeth moved** to approve the proposed budget and have the City Attorney draft the FY 2017 budget ordinance; **seconded by Mr. Billington**. All members voted aye.
