

## MINUTES OF THE COUNCIL

January 23, 2020

5:00 P.M.

The Murray City Council met in a special called session on Thursday, January 23, 2020 at 5:00 p.m. in the Council Chambers of City Hall with Mayor Bob Rogers presiding.

Mayor Rogers called the meeting to order and welcomed Council members and guests.

### **Mayor's Report**

Mayor Rogers stated the Student Government Association of Murray State University passed a Resolution thanking the City Council for the speed tables.

**Ordinance Number 2020-1791** (first reading) an ordinance amending City of Murray Code of Ordinances, §32 Departments, Boards, and Commissions, specifically §32.90; §32.92; §32.96; §32.98 and §32.99 to further define the purpose of the tree board and to refer violations under this ordinance to the Code Enforcement Board for enforcement. **Dr. Strieter made a motion to amend the first reading of Ordinance Number 2020-1791, to include in §32.93 an ex-officio member of the City Beautification Board to the Tree Board; seconded by Ms. Rouse. All members present voted Aye.**

**Municipal Order Number 2020-068** appointing Dan Renick to the Murray Calloway Hospital Board for a term of four (4) years. Said term will expire March 31, 2024. **Mr. Bell moved for approval; seconded by Mr. Bolin. All members present voted Aye.**

With no other business before the Council, **Mr. Bell moved to adjourn; seconded by Dr. Strieter. All members present voted Aye.**
