

**MURRAY PLANNING COMMISSION MINUTES  
REGULAR MEETING  
TUESDAY, OCTOBER 15, 2019  
4:30 P.M.**

The Murray Planning Commission met in regular session on Tuesday, October 15, 2019 at 4:30 p.m. in the council chambers of City Hall at 500 Main Street.

**Commissioners Present:** Tom Kind, John Krieb, Robin Zhang, Jim Foster and Martin Milkman

**Commissioners Absent:** Bobby Deitz and Marc Peebles

**Also Present:** Maurice Thomas, Jeremy Buchanan, Attorney David Perlow, and Zach Warren

Chairman Tom Kind called the meeting to order and asked Maurice Thomas to call the roll. At this time the Chairman asked if there were any changes to the minutes from the regular Planning Commission meeting on September 17, 2019.

**John Krieb made a motion to approve the minutes from the regular Planning Commission Meeting on September 17, 2019 as presented. Jim Foster seconded the motion and the motion carried unanimously.**

**Public Hearing: Approval of changes to the Transportation Element of the Comprehensive Plan for the City of Murray:** Jeremy Buchanan reviewed the changes/corrections that were made to the Transportation Element of the Comprehensive Plan. He explained that he has worked with IT Staff about posting this to the City's website for review so that this can be approved along with the other elements in the January time frame. Jeremy added that they had decided to make updates to each element of the Comprehensive Plan as changes occurred instead of waiting every five years to update the entire document; thus, keeping the document more current. The Commissioners were given time for comments, corrections and questions. Jeremy said that he would make the changes to the proposed Transportation Element according to the discussion. He also said that he would talk to KYTC concerning some of the traffic light sequencing issues to better accommodate traffic patterns.

Chairman Kind opened and closed the public hearing (since there was no public audience present). There was no vote taken on the proposal. The Commissioners decided to vote on all of the elements at one time during January.

**Annual Election of Officers:** The Commission annually elects a Chairman, First Vice-Chairman and Second Vice-Chairman for a one year term of office beginning on January 1. Chairman Kind noted that some of the Commissioners terms are due to expire and at this point, they do not know if they will be re-appointed or not. He then stated that he was open for nominations for the officers.

**John Krieb made a motion to continue with the officers that are currently serving pending renewal from the Mayor. Jim Foster seconded the motion and the motion carried with a unanimous vote.**


