## MURRAY PLANNING COMMISSION MINUTES REGULAR MEETING TUESDAY, NOVEMBER 13, 2018 4:30 P.M.

The Murray Planning Commission met in regular session on Tuesday, November 13, 2018 at 4:30 p.m. in the council chambers of City Hall at 500 Main Street.
