## ORDINANCE 2019-1778

AN ORDINANCE AMENDING CITY OF MURRAY CODE OF ORDINANCES CHAPTER 32, DEPARTMENTS, BOARDS, AND COMMISSIONS, SPECIFICALLY, \$32.71 (A); CABLE COMMUNICATION COMMISSION, MEMBERSHIP, TO CLARIFY COMPOSITION AND TO ENSURE COMPLIANCE WITH OTHER ORDINANCES.

WHEREAS, the City of Murray desires to amend Chapter 32, DEPARTMENTS, BOARDS AND COMMISSIONS, specifically \$32.71 (A), Cable Communication Commission, Membership, in order to clarify composition and ensure compliance with other ordinances; and

WHEREAS, the Murray City Council has reviewed and discussed the following proposed changes to Chapter 32, \$32.71 (A) DEPARTMENTS, COMMISSIONS, AND BOARDS, Cable Communication Commission, Membership, of the City Of Murray Code Of Ordinances and believe that the proposed changes are reasonable and necessary.

BE IT ORDAINED by the City Council of the City of Murray, as follows:

AMENDMENT: ADDITIONS, ASSERTIONS & CHANGES:

CHAPTER 32: DEPARTMENTS, BOARDS, AND COMMISSIONS

Subchapter \$32.71 (A) is amended to read as follows:

(A) The Commission shall consist of six five (5) members, two one (1) of whom shall be members a member of the City Council. All members shall be residents of the city, and shall be appointed by the Mayor, subject to the approval of the City Council. Each member shall serve a term of four years. In the appointment of the Cable Commission members, the membership should represent an equal balance between the cable providers in the city consist of a minimum of two (2) members from each cable provider. The Local Commissioners shall be compensated twenty-five dollars (\$25.00) per meeting attended.

Nothing in this Ordinance hereby adopted shall be construed to affect any suit or proceeding impending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed as cited in this Ordinance; nor shall any just or legal right or remedy or any character be lost, impaired or affected by this Ordinance.

All other sections and provisions of the Ordinances for the City of Murray, not specifically amended herein, shall remain in full force and effect and shall not be considered amended and shall be incorporated by reference as if fully stated herein.
