ORDINANCES CITY OF MURRAY, KENTUCKY

AN ORDINANCE DECLARING THE DESIRE AND INTENTION OF THE CITY OF MURRAY TO ACCEPT THE
PROVISIONS OF AN ACT OF THE GENERAL ASSEMBLY
OF THE COMMONWEALTH OF KENTUCKY, REGULAR
SESSION; 1942, KNOWN AS HOUSE BILL NO. 146
AND TO OPERATE AN ELECTRIC PLANT UNDER THE
PROVISIONS OF SAID ACT AND TO AUTHORIZE THE
MAYOR OF SAID CITY TO APPOINT AN ELECTRIC
PLANT BOARD AS PROVIDED IN SAID ACT AND
RELATING TO THE APPOINTMENT AND POWERS OF
THE MEMBERS OF SUCH BOARD.

Whereas, the City of Murray (hereinafter celled "City")
has, pursuant to a Sale Agreement between Tennessee Valley Authority, the City, and others, dated as of May 13, 1942, acquired an electric distribution plant and system (such plant and system, as hereafter improved and extended, being hereinafter called the #Electric Plant") in and surrounding the City for the purpose of supplying the City and the inhabitants with electricity for light and power, and

WHEREAS, the City wishes to elect to operate the seid Electric Plant under the provisions of an Act of the General Assembly of the Commonwealth of Kentücky, Regular Session, 1942, known as House Bill No. 146 (hereinafter referred to as the "Act"), and desires to accept and agree to all of the provisions of the Act as they may be from time to time amended by the Acts of the General Assembly of Kentucky, and

WHEREAS, the City desires to provide for the creation and establishment of an Electric Plant Board as provided in the Act and to confer upon such Electric Plant Board all powers now possessed by the City relating to the operation of the Electric Plant,

NOW, THEREFORE, be it ordained by the Board of Council, of the City of Murray, Kentucky, as follows:

Section 1. ACCEPTANCE OF AND OPERATION UNDER THE ACT.

The City hereby declares its desire and intention to accept and operate the Electric Plant under the provisions of the Act and to accept and agree to all of the provisions of the Act and as they may be from time to time amended by the Acts of the General Assembly of Kentucky.

Section 2. AUTHORIZETION OF AN ELECTRIC PLANT BOARN.

The Mayor of the City is hereby authorized to appoint, subject to the approval of his appointments by the Board of Council,

a board to be known as the "Electric Plent Board of the City of Murray, Kentucky" (hereinafter called "Board") to own and operate the said Electric plant, as provided in the Act and this Ordinance.

Section 3. SALARIES OF BOARD MEMBERS.

The salary of each member of the Board appointed pursuant to this Ordinance shall be \$300.00 dollars per annum.

Section 4. POWERS OF THE BOARD.

All properties, real, personal, and mixed, tangible and intangible, acquired and owned by the City, used or held for use in connection with the Electric Plent, shall be and are hereby sold, conveyed, transferred, assigned, and set over to the Board upon its appointment and qualification, and all such properties shall be owned and held by and in the name of the Board. The Mayor and City Clerk are hereby authorized to execute such instruments as the Board may deem necessary to perfect its title to such properties.

Section 5.

INCORPORATION OF ACT BY REFERENCE.

The provisions of the Act, insofar as they relate to the establishment, powers, and responsibilities of the Board, the appointment, powers, and responsibilities of the superintendent, secretary-treasurer, and other employees, or the operations of the Board, are hereby incorporated herein.

Section 6. REPEAL OF CONFLICTING RESOLUTIONS AND ORDINANCES.

All resolutions or ordinances, insofar as they may conflict harewith, are hereby repealed, and this Ordinance shall become effective from and after its passage.

This ordinance shall take effect from and efter its passage, and shall be published by the posting of typewritten copies.
