

**MINUTES OF
COUNCIL**

April 11, 2019
6:30 P.M.

The Murray City Council met in regular session on Thursday, April 11, 2019, at 6:30 p.m. in the Council Chambers of City Hall with Mayor Bob Rogers presiding.

Mayor Rogers called the meeting to order and welcomed Council members and guests.

After a moment of reflection, Terry Strieter led the Pledge of Allegiance to the Flag.

The minutes of the Council Meeting of March 28, 2019, were presented for approval. **Mr. Roberts moved for approval with grammatical changes; seconded by Ms. Rouse. All members present voted Aye.**

Mayor's Report

Mayor Rogers recognized City Beautification Committee members Alice Rouse and Terry Strieter. Ms. Rouse stated the Clean-up Day is scheduled for Saturday, April 13th. She stated volunteers will meet at 9:00 a.m. either downtown or at the Park. Ms. Rouse stated if it rains, the makeup day will be April 27th. Dr. Strieter stated the Committee looks forward to many citizen volunteers.

Mayor Rogers recognized Public Safety Committee Chair, Wesley Bolin. Chair Bolin reported the Committee had a meeting prior to the Council meeting. Chair Bolin stated one item was on the agenda, Ordinance Number 2019-1774. Mr. Bolin explained the changes in the ordinance, which include the reduction in the requirement of the new construction of cul-de-sacs, and a 4% overall reduction of the fee schedule. He stated the Committee voted unanimously to send the Ordinance to the full Council for the first reading. **Mr. Roberts moved for approval of the report; seconded by Dr. Strieter. All members present voted Aye.**

Ordinance Number 2019-1774 an ordinance amending City of Murray Code of Ordinances Chapter 92: Fire Prevention, specifically to amend paragraphs, §92.00, §92.01, §92.04, and §92.06 and Table 92.06 Fee Schedule, to clarify terms and to ensure compliance with other ordinances.

Dr. Young made a recommendation for the Public Safety Committee to enact an ordinance with penalties to make it illegal to throw grass clippings in the street. Mr. Osborne stated the City currently has an ordinance prohibiting debris in the street that will be looked at.

Ms. Rouse made a recommendation for the City of Murray to become a Tree City.

With no other business before the Council, **Mr. Bell moved to adjourn; seconded by Ms. Elder. All members present voted Aye.**

The meeting adjourned at 6:37 p.m.
