### MINUTES OF THE COUNCIL

May 12, 2022 6:30 P.M.

The Murray City Council met in regular session on Thursday May 12, 2022 at 6:30 p.m. in the Council Chambers at City Hall with Mayor Bob Rogers presiding.

Mayor Rogers called the meeting to order and welcomed Council members, staff, and guests.

After a moment of reflection, Ms. Seiber led the Pledge of Allegiance to the Flag.

**Mayor's Report:** The Mayor stated he wanted to remind everyone there would be an open house for the new fire station on Sunday May 15, 2022 beginning at 1:00 P.M.. Everyone is welcome to attend. Brian Edwards and Boone Chambers hosted a fundraiser, Bourbon and Bow Ties, which raised \$112,000.00 to support the renovation of the pool. There was an additional \$1,500.00 dollar check donated at this time as well.

Cemetery Committee Report Mayor Rogers recognized Co-Chair Ms. Rouse to give an update on the Cemetery Committee meeting that was held prior to Council. Ms. Rouse stated there were two items they wanted to bring before Council. Ms. Rouse stated Justin Franklin would not be able to paint the mural located at the mausoleum. The Committee has a bid from Ms. Holly Beauchamp totaling \$2,232.40. This cost would cover all expenses. Ms. Beauchamp is from the Bowling Green area and has experience with this type of work.
