MINUTES OF THE COUNCIL

June 8, 2023 6:30 P.M.

The Murray City Council met in regular session on Thursday, June 8, 2023, at 6:30 p.m. in the Council Chambers at City Hall with Mayor Bob Rogers presiding.

Mayor Bob Rogers called the meeting to order and welcomed Council members, staff, and guests.

The minutes of the Council meeting of May 25, 2023, were presented for approval.

Mr. Bohannon moved for approval of the minutes; seconded by Ms. Rouse. All members present voted Aye.

Insurance Committee Report Mr. Bell stated the staff sent out request for insurance proposals, Property, Liability, and Workers' Compensation. We received two proposals, Travelers Insurance and Kentucky League of Cities. The committee voted to recommend KLC, as the best option for the City of Murray.

Ordinance 2023-1846 (Second Reading) an ordinance amending City of Murray Code of Ordinances Chapter 115: Solicitors and Peddlers, specifically §115.02: Using Streets or Public Premises; Exception; and §115.06 Mobile Food Vendors Pilot Program Policy; and to include a new section, specifically §115.07: Transient Business Regulations, in order to support Mobile Food Vendors to create new jobs, clarify the use of streets or public premises and to establish certain regulations for Transient Businesses.

Finch, as R-2 (Single-Family Residential). (No Vote)

Ordinance 2023-1850 (First Reading) an ordinance of the City of Murray, Kentucky annexing a 16.935 acre tract of land, specifically being Tract 1, PVA Parcel Number 033-0-0027, located at 1169 Robertson Road South, Murray, KY, approximately 1250 feet to the North of Wiswell Road, owned by Janet B. Finch and contiguous to the present city limits. (No Vote)

Ordinance 2023-1851 (First Reading) an ordinance enacting and adopting a supplement to the Code of Ordinances of the City of Murray, Kentucky. (No Vote)

<u>Municipal Order 2023-026</u> reappointing Danny Brittain to the Code Enforcement Board. Said term to expire June12, 2026.
